The global standard for information security, **ISO/IEC 27001 sets guidelines for a robust information security management system (ISMS)**. It shows the company's commitment to safeguarding intellectual property and preventing breaches.

Yalantis' ISO 27001 certification validates that the company:

- protects clients' intellectual property and confidential data
- maintains enterprise-grade information security controls for confidentiality, integrity, and system/data availability, such as access controls, encryption, and monitoring
- conducts risk assessments to identify emerging threats and vulnerabilities to information assets
- puts incident response plans in place to quickly recover from any potential breach
- manages third-party service providers and secures supplier relationships
- implements personnel security measures like security awareness training
- conducts internal ISMS audits at planned intervals to ensure conformity to requirements

ISO 27701 offers guidance on implementing a **privacy information management system (PIMS)** to responsibly manage personally identifiable information (PII). Its principles align with **data protection principles in regulations like the GDPR**.

- supports global data privacy regulations
- provides a clear and accessible privacy policy
- assesses privacy risks from PII processing
- maintains and monitors PIMS effectiveness
- ensures legal compliance on data privacy
